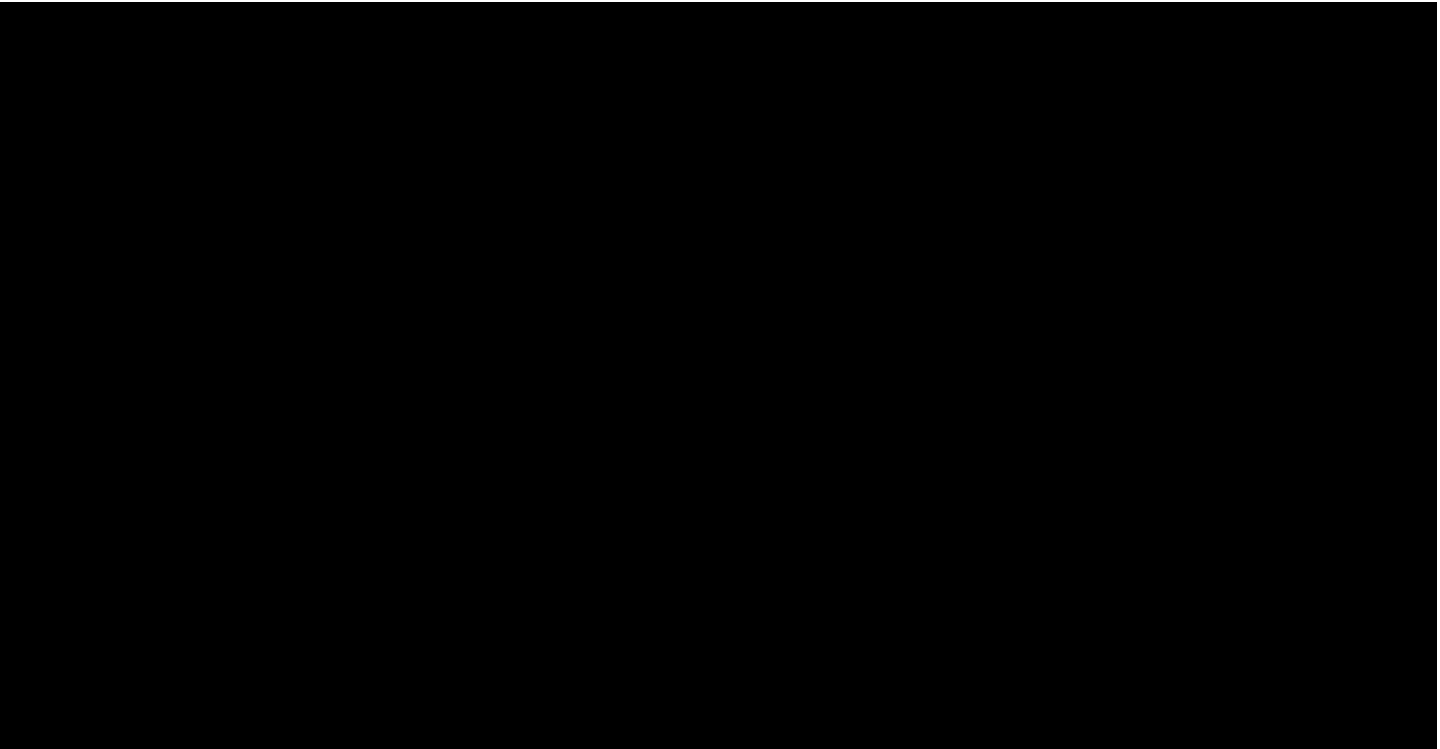

Assault

On Monday June 1, 2020 at approximately 7:21PM, I Officer Daniel Miranda 59 was dispatched to Starlite located at 1106 East University Drive for an accident turned in to a disturbance. Upon arrival I made contact with off duty Sergeant Manny Alvarez S20. See Sgt. M Alvarez S20 supplement report case number 20-26022 for details. Sgt. Alvarez said that he did not see the accident but got off his vehicle due to him seeing a disturbance going on. He said that there was a witness inside the restaurant. Officer Adan Moreno 99 arrived at my location and he went inside the restaurant to look for the witness. I made contact with Sydnee Renee Rivera and her boyfriend Troy Anthony Trevino. Sydnee was driving a black GMC Terrain Texas license plates MRX6504. I also made contact with Luis Gabriel Alamia and his mother Marcelina Alamia. Luis was driving a red 2018 Ford F150 Texas license plates LRB8491. Troy was a passenger in the Terrain and Marcelina was a passenger in the F150. Troy said that Sydnee was pulling in to Starlite from the east bound lanes. Troy said that Sydnee pulled in to the parking lot and that's when Luis in his F150 attempted to also get in the drive thru lane. Troy said that Luis was facing west in front of the restaurant in the parking lot. Troy said that Luis was not letting Sydnee get in. He said that he got off the Terrain and got in front of the F150 to stop Luis from moving forward so Sydnee could get in line. Troy said that Luis got off his truck and confronted Troy. He said that they exchanged words and stated that Luis tapped him on his chest. Troy said that Luis then got back in his truck. He said that Luis moved forward pushing Troy back with the F150 front grill hitting Sydnee's Terrain left rear quarter with Luis's F150 front right grill. I did notice damage to the Terrain's left rear quarter.

I then spoke to Luis and he said that he never hit Troy with his truck. He said that he did get off the truck to confront Troy because Troy was blocking him. Luis said that he did tap Troy on the chest but it was not hard it was a light tap. He said that Troy then pushed him by his shoulders. Both Troy and Luis wanted to file assault charges. I gave both of them a case number and advised them that I was going to file on both of them since they both wish to file charges. I provided them with a case number and they both left location.

Officer Moreno 99 advised that the witness had left location before he could make contact with him. He said that he left a business card with the case number with staff in case the male returns. Officer Moreno also stated that he reviewed the cameras and it does not show the incident. He said that they only have one camera in the front and it only captures the F150 rear. The video only shows the F150 moving forward.

On 06-01-2020 at approximately 19:20hrs I, Sgt. Manuel Alvarez#20 (off duty) had just picked up some food through the drive through located at 1106 E. University Drive. (Starlight) As I drove northbound through the parking lot towards University Drive I looked towards my left (west) and observed two males arguing in the parking lot. I observed one male who I recognized as Louie Alemia by a large Red pick up and another male later identified as Troy by a smaller black suv vehicle.

I advised both Troy and Louie to stop arguing and introduced myself as an off duty police officer. Mr. Alemia was on the phone and he recognized me right away. I advised him to get back in his truck and wait for the police to arrive and he did. I then made contact with Troy who was clearly agitated and stated that Mr. Alemia had struck him with his truck. [REDACTED]

At least two fire department personnel maybe three were also at location helping separate the males but I was uncertain if they had seen what had occurred. Troy told me that he was in the passenger seat and that his wife was driving. At that point I also made contact with a female by the black suv and she told me she was driving the suv and was Troy's wife.

Troy told me that they were on the street (University) facing east and was drying into the parking lot when he observed a large truck facing west in the parking lot and he said the male in the truck tried to cut them off from the drive through line. Troy stated that he got off his vehicle and tried to get between his vehicle and the truck so that his wife can get in the drive through. Troy stated they were there first and the male was trying to cut in.

Troy then stated that Louie then got back in his truck and started to move towards him with his truck causing the truck brush guard to make contact with his body and push him back towards his vehicle and causing the truck to strike his vehicle on the rear quarter panel on the driver's side. I did observe that Louis's truck front right was in contact with the suv's rear quarter panel on the driver's side but could not see what kind of damage it had caused.

Troy stated that he was upset when he got pushed back and admitted to striking the hood of Louis's truck with his fist but I could not see any damage on the truck do to rain that was coming down.

At this time Officer Daniel Miranda #59 and Officer Adan Moreno #99 arrived at location. I briefed them in to what I had been advised by both males and then I walked back towards the restaurant too see if there were any witnesses.

I made contact with a male by the front door. The male stated that he was related to



the owners at location and stated that he did not see [REDACTED] at location but did state that he observed the male in the big truck drive his truck towards the other male and hit or push the other male with his brush guard. I advised the male to wait for police to give his statement.

I then walked over to the officers and advised him of the witness. No other action was taken on this report.
